Collateral clauses and instruction on right to appeal

Collateral clauses

All equipment which corresponds to the approved type is to be identified according to the applied regulation.

The individual production of serial fabrication must be in exact accordance with the approval documents. Changes in the individual production are only allowed with express consent of the Kraftfahrt-Bundesamt.

Changes in the name of the company, the address and the manufacturing plant as well as one of the parties given the authority to delivery or authorised representative named when the approval was granted is to be immediately disclosed to the Kraftfahrt-Bundesamt.

Breach of this regulation can lead to recall of the approval and moreover can be legally prosecuted.

The approval expires if it is returned or withdrawn or if the type approved no longer complies with the legal requirements. The revocation can be made if the demanded requirements for issuance and the continuance of the approval no longer exist, if the holder of the approval violates the duties involved in the approval, also to the extent that they result from the assigned conditions to this approval, or if it is determined that the approved type does not comply with the requirements of traffic safety or environmental protection.

The Kraftfahrt-Bundesamt may check the proper exercise of the conferred authority taken from this approval at any time. In particular this means the compliant production as well as the measures for conformity of production. For this purpose samples can be taken or have taken. The employees or the representatives of the Kraftfahrt-Bundesamt may get unhindered access to the production and storage facilities.

The conferred authority contained with issuance of this approval is not transferable. Trade mark rights of third parties are not affected with this approval.

Instruction on right to appeal

This approval can be appealed within one month after notification. The appeal is to be filed in writing or as a transcript at the **Kraftfahrt-Bundesamt**, **Fördestraße 16**, **DE-24944 Flensburg**.





- •After crash accident, the damage of the the baby car seat may not be found instantly, but it is not safe any more, therefore, please change a new one.
- •The car seat must be fixed well, even there is no baby in the car, because it may hurt other passengers in case of crash or a sudden brake.
- Do not use any lubricant to the moving parts of the car seat.
- •Do not use the car seat without cloth cover. Please return the cloth cover to the original state after leaning.
- Do not refit the car seat, because it will change the safety performance of the carseat.
- •Do not expose the car seat to burning sun, the metal and plastic parts of the car seat may be brning hot. Please check the temperature of the car seat before fixing baby to avoid hurting baby. Also burning sun may fake the color.


- •Use 2-point car belt to fix your baby safety seat may lead to sever injury or death to your child if crash happened.
- •Please tell your baby not to play with the buckle.





- •2-point car belt is forbidden to fix your baby.
- Please install the car seat and parts correctly according to the User Instruction, to ensure car seat not stuck by the door or seat of car.
- •Belt should be installed correctly, ensure the belt be in the pelvis.
- No twine or twisting of the belts.
- •Car seat must be changed after strong crash.
- Car seat without our certification and user instruction or refitted is very dangerous.
- •Do not leave baby alone on the car seat.
- Luggage and other items should be properly placed after car crash.
- •Car seat without cloth cover cannot be used, cloth cover not provided by manufacturer cannot be used, it influences the performance of car seat.
- Force bearing point unmarked cannot be used when installing, any doubt please contact manufacturer or the ratailer.






5.2 Fix the car seat by car seat belt

• Put the baby car seat onto the car seat along the driving direction. (Figure 1)




• Pull out the car belt long enough. Then let the car belt pass through the car belt passage behind the seat cushion. (Figure 2)

Notice: the car belt must pass through the passage from the front side of the seat firstly, then go beneath the safety belts and reach the other belt passage, and then come out of the passage from the back side to the front side. The car belt must not hold down the safety belts of baby car seat.




The car belt goes beneath the safety belts and reaches the other belt passage, and then comes out of the passage from the back side to the front side.



• Open the seat cushion and pull the car belt out of the belt passage. (Figure 3)



- ●Lock the car belt until you hear a "click" sound.(Figure 4)
- Following the order ① ② ③ ④ , fasten the car belt with hands. Now the installation is complete. (Figure 5)

6.Usage of 5-point harness system

6.1 Using 0f 5-point harness

•Extend the safety belt ——Push the central adjuster with one hand and pull outward the safety belts with the other hand(caution! do not pull the shoulder pad).(Figure 6)



• Tighten the safety belt - pull the adjusting strap along the arrow direction .(Figure 7)



6.2 Height adjustment of 5-point harness

• Firstly extend the safety-belt (Refer to Figure 6), and take down the safety-belt from the Tee buckle on the back of the backrest (Figure 8).



•Pull open the polypropylene shoulder strap mounting clamp (Figure 9).



•Pull safety belts and shoulder straps out of the baby car seat from the front side. (Figure 10)



•Put the safety belts and shoulder strapsback into the seat in appropriate slot. (Figure11)

Caution: make sure both sides of the straps are at same level and not twisted.

•Reset the safety-belt into the Tee buckle on the back of the backrest, and fix the polypropylene shoulder snap well. (Figure 12)



•Put the child into the baby car seat, lethis/her arms go through the safety belt.(Figure 15)



•Pull the safety belt in front side to make sure it has been properly installed.(Figure 13)



• Put the two buckle tongues together and insert into the buckle until you hear a "click" sound. (Figure 16)



6.3 Fixation of 5-point harness

•Loose the safety belt (refer to Figure 6), then press the red button on the buckle to release it until hearing the "click" sound.(Figure 14)



• Draw the adjusting strap forwardly to fastenthe harness system. (Figure 17)


Caution: The proper tightness is one finger space between the safety belt and the child's body. Correct position of the buckle is ate the crotch of the child not his/her belly.

•Put the baby car seat onto the front facing car seat after the 5-point harness system being removed(refer to Page 20-21 Figure25-29).(Figure 18)



• Use the headrest adjuster to lift the headrest into an appropriate height. (Figure 19)

Caution: ①The headrest height has 6 levels. ②Before use the baby car seat, please adjust the headrest until of the upper belt rout guider and the child's shoulder are at same level.



• Pull out the car belt. (Figure 20)



8.2 Baby fixation of group III

- Take the belt guidance out of the base and pull out the adjuster strap in the direction of arrow(as shown in picture 1) to make sure the shoulder strap between the belt guidance and baby car seat is long enough(Figure 25).
- •Let both shoulder belt and waist belt go through the belt route guider on the other side, then buckle the car belt until you hear a "click"sound. (Figure 29)

Caution: The shoulder belt must go over middle of children's shoulder. And the waist belt must go over children's pelvis as low as possible.

•Fasten the belt and adjust the length of the positioning belt, clip the vehicle belt into the positioning buckle, which is the same high or a little higher than the child's shoulder. (Figure 30)

9. Maintenance of baby car seat

9.1 Cleaning of cloth cover

1 Do not use baby car seat without cloth cover.

- •Cloth cover can be removed. Wash it with a mild detergent in warm water(water temperature does not exceed 30°C), natural dry, not dehydration
- Plastic parts can be cleaned with soap and water, do not use strong detergents (such as solvent).
- •eat belt can apply mild soap to clean.
- •Shoulder strap can be removed with mild soap water to clean.

9.2 Dismantlement of cloth cover and 5 points harness

• Press the red button on the buckle, pull out the safety belt long enough(refer to Page12 Figure6), open the buckle. Operating sequence 123 (Figure25)



- •Turn to the back of the car seat: dismattle the safety belt from the Tee buckle; receives the snap buttons from the shoulder
- re se the snap buttons from the shoulder straps.(Figure 26)


• Pull the safety belt out of the safety lock tongue hole .(Figure 27)



● To take off the headrest cover, simply pull open the black fixing elastic strap in order of ① ② ③ ④ . (Figure 30)



• Turn to the bottom side of car seat : 1 pull the safety belt out of the safety belt hole; 2 dismantle the tri-glide from the crotch strap, then 5-point harness system and the cotton pad can be removed consequently. (Figure 28)



• Release all four snap-fasteners. (Figure 31)



•Remove the inner headrest. (Figure 29)



•Hold the base with one hand and push the backrest backwards with the other hand. Then the backrest fabric cover can be removed.(Figure 32)

9.3 Installation of cloth cover and 5 points harness

•Put the base cover on the base, carefully press the cover into the belt route guider. (Figure 34)



•Then adjust the rest parts to get a fine surface. (Figure 35)



•Attach the two hooks on lower side of the backrest (with fabric cover) to corresponding slots on base. Push the backrest with one hand and spinning it with the other hand to put the backrest into position. (Figure 37)



•Open the headrest cover, a black elastic strap can be seen. (Figure 38)







10. Warranty condition and warranty card

Warranty period is 1 year since purchased, Warranty scope includes factory manufacturing or material problems.

Warranty card is an important quality assurance certification, please keep it well in the warranty period. Meanwhile, please keep your sales vouchers and related documents.

Warranty does not cover:

- •The natural phenomena in the process of using, or the damage of the car seats due to excessive pressure.
- The damage of the car seats due to inappropriate or incorrect use.
- •The damage of the car seats due to car accidents.

Warranty covers:

Put the endergonic cushion on the baby car seat and pull out the crotch protector from the endergonic cushion.

Put the base cloth on the baby car seat, fix the snap-fasteners well on both sides.

- 1. Make the safety belt buckle through the safety belt hole of the base cloth.
- 2. Make the crotch protector through the crotch protector hole of the base cloth.
 - 3. Put the safety belt adjustment belt out from the base cloth hole.
